RE: August 2011 Drug Test Statistics (Adult Arrestees)

Drug testing of adult arrestees for August 2011 revealed an overall positive test rate of 33% consistent with July 2011. Cocaine revealed a 3% decrease; multi-positives revealed a 1% increase; opiates and PCP revealed a 2% increase; amphetamines remained consistent with July 2011.

The breakdown of August 2011 test results is as follows:


