RE: December 2010 Drug Test Statistics and Year-End Data (Adult Arrestees)

Drug testing of adult arrestees for December 2010 revealed a 1% increase in the overall positive test rate (up from 35% to 36%) from November 2010. PCP positives revealed a 1% increase from November 2010. Amphetamines, Opiates, Cocaine and Multi-positives remained consistent from November 2010.

The breakdown of December 2010 test results is as follows:
