RE: September 2010 Drug Test Statistics (Adult Arrestees)

Drug testing of adult arrestees for September 2010 revealed that the overall positive test rate remained consistent from August to September 2010. Cocaine and Opiate positives revealed a 1% decrease respectively from August 2010. Multi-positives revealed a 1% increase from August 2010.

The breakdown of September 2010 test results is as follows:
