RE: March 2012 Drug Test Statistics (Adult Arrestees)

Drug testing of adult arrestees for March 2012 revealed a 2% increase in the overall positive test rate (up from 28% to 30%) from February 2012. Cocaine revealed a 2% increase; multi-positives and amphetamines revealed a 1% increase; PCP revealed a 1% decrease and opiates remained consistent with last month.

The breakdown of March 2012 test results is as follows:
