RE: August 2012 Drug Testing Statistics

August 2012 Adult Drug Test Statistics

Drug testing of adult arrestees for August 2012 revealed a 2% increase in the overall positive test rate (up from 28% to 30%) from July 2012. Opiates levels revealed a 3% percent increase. Multi-positives, cocaine, amphetamines and PCP levels remained consistent with last month.

The breakdown of August 2012 test results is as follows:

August 2012 Juvenile Drug Test Statistics

Drug testing of juveniles (both lockup and community cases) for August 2012 revealed a 1% decrease in the level of marijuana use and a 1% decrease in amphetamine use from July 2012. Multi-positives, cocaine and PCP remained consistent with last month.

The Juvenile Drug Testing Unit tested 165 respondents prior to their appearance in August. Of the 158 lockup cases, 78 (49%) tested positive. Of the 7 community cases, 2 (29%) tested positive for marijuana. The combined positive rate was 48%, down from the previous month.
