## MEMORANDUM

RE: March 2011 Drug Test Statistics (Adult Arrestees)

Drug testing of adult arrestees for March 2011 revealed a 4% increase in the overall positive test rate (up from 33% to 37%) from February 2011. Cocaine and PCP positives revealed a 1% increase; multi-positives revealed a 2% increase, and amphetamines and opiates positives remained consistent from February 2011.

The breakdown of March 2011 test results is as follows:
