RE: April 2011 Drug Test Statistics (Adult Arrestees)

Drug testing of adult arrestees for April 2011 revealed a 2% increase in the overall positive test rate (up from 37% to 39%) from March 2011. Cocaine and multi-positives revealed a 1% decrease; PCP positives revealed a 1% increase, and amphetamines and opiates positives remained consistent from March 2011.

The breakdown of April 2011 test results is as follows:
