RE: October 2010 Drug Test Statistics (Adult Arrestees)

Drug testing of adult arrestees for October 2010 revealed a 2% increase in the overall positive test rate (up from 34% to 36%) from September 2010. Opiates and Multi-positives revealed a 1% decrease respectively from September 2010. Cocaine positives revealed a 2% increase from September 2010. PCP positives revealed a 2% decrease from September 2010.

The breakdown of October 2010 test results is as follows:
