MEMORANDUM

- RE: <u>April 2008 Juvenile Drug Testing Statistics</u>

Drug testing of juvenile arrestees for April 2008 revealed a decrease in the levels of substance abuse detected for marijuana and PCP, which were down 1% each from March to 55% and 2%, respectively. The level of substance abuse detected for cocaine decreased by 2% from the previous month to 1%, while amphetamines remained the same at 2%.

The Juvenile Drug Testing Unit tested 227 respondents prior to their initial hearing in April. Fifty-six percent (56%) of the 194 Lockup cases tested positive. Fifty-eight percent (58%) of the 33 Community cases tested positive. The combined positive rate was 56%.


