RE: Juvenile Drug Testing Statistics for Dec. 2005 and Year-End Data

Drug testing of juvenile arrestees for December 2005 revealed an increase in the level of substance abuse detected for cocaine, which was up 1% from November, to 4%. The level of substance abuse detected for marijuana was down 2% from the previous month, to 52% while PCP remained the same at 2%.

The Juvenile Drug Testing Unit tested 203 respondents prior to their initial hearing in December. Fifty-five percent (55%) of the 189 Lockup cases tested positive. Twenty-nine percent (29%) of the 14 Community cases tested positive. The combined positive rate was 53%, down 1% from November.


