RE: <u>November 2008 Juvenile Drug Testing Statistics</u>

Drug testing of juvenile arrestees for November 2008 revealed an increase in the level of substance abuse detected for marijuana, which was up 4% from October to 54%; amphetamines and cocaine were up 1% each to 2% and 1%, respectively. The level of substance abuse detected for PCP decreased by 1% to 2%.

The Juvenile Drug Testing Unit tested 211 respondents prior to their initial hearing in November. Fifty-three percent (95) of the 179 Lockup cases tested positive. Fifty-nine percent (19) of the 32 Community cases tested positive. The combined positive rate was 54%.


